Description of Records Sought

- A high resolution map of the Allenwood Wastewater Agglomeration including all pumping stations and the WWTP
- 2. Details of the maintenance contract with EPS for the Allenwood Wastewater Agglomeration or any parts thereof, including the WWTP. Specifically:
 - a. Starting and ending date of the contract
 - b. Terms or Service Level Agreement of the contract
 - c. The cost of the contract broken down as granular as possible
- Records of unplanned breakdowns for the Allenwood Wastewater Agglomeration or any parts thereof, including the WWTP. Specifically:
 - a. Dates and times and the nature of the breakdown
 - b. Cost of resolving the breakdown
- 4. Records relating to the regular transfer of material using the manhole in the middle of the road from the Allenwood North section of the Agglomeration by Boyne Waste Services. Specifically:
 - a. Dates and times for each transfer
 - b. Type of material being transferred
 - c. Destination of that material
 - d. Costs of each transfer or costs of any associated contract with EPS or Irish Water
- A copy of the written procedure and / or any checklists that are used in determining whether or not a WWTP will reach capacity in the next three years in order to answer the relevant question on the Annual Environmental Report for that WWTP.
- 6. A copy of the detailed evaluation and any calculations that were done when determining if the limit of the Allenwood WWTP would be exceeded in the next three years. This should include the list of housing developments that have been granted permission or that Irish Water have been notified are in planning stage.
- 7. A copy of the written procedure that is followed when Irish Water receive notification of a planning application for a development that intends to connect to a public sewer system.
